I am attaching the Appeals for Aid 2020 Application for all to have in the event a member, division, county or state would like to submit an entity for review at the 2020 National Convention. I will be sending to the National Webmaster Sandi Swift to be added to the National Website under Missions & Charities where all the other forms are. It is a fillable application, so you only need to download fill out and send back.

In addition, the committee has requested from National President Sheyer to have a minimum of a 2-hour allotment for the Missions & Charities Committee & the Appeals for Aid Committee as suggested at the 2018 National Appeal's for Aid Committee.

The committee is submitting a constitutional change to National President Sheyer to add process and procedures for the due dates etc.

**Current Constitution reads: ARTICLE XV, Section 8, Subsection G:**  
***Appeals for Aid are intended to provide limited aid to charities at the National Convention. All appeals for aid requests must be from a 501(c)(3) charity and submitted to the Missions & Charities Officer 45 days prior to the Convention. The Missions & Charities & Appeals for Aid Committees will bring these recommendations to the National Convention delegates for approval.***
